# Intended Use / Indications for use

**MEDORAH®** Colonoscopy Pants are intended for single-patient use in clinical settings to maintain hygiene and minimize the risk of contamination during colonoscopy procedures. These lightweight shorts feature a rear slit design to allow procedural access while maintaining patient comfort.

The pants also serve as a barrier to reduce the transfer of microorganisms, body fluids, viruses, and other contaminants between the patient and medical staff.

**MEDORAH® Colonoscopy Pants** is supplied non-sterile and is intended for single use only.

#### **Device Description**

**MEDORAH®** Colonoscopy Pants are made from a tri-layer, non-woven fabric that is water-repellent, breathable, and skin-friendly. The shorts-style fit with an elastic waistband ensures ease of wear and accommodates various body types. These pants support infection control protocols and promote efficient clinical workflows.

#### **Procedure**

- Open the packaging carefully and inspect the product for any signs of damage.
- Examine the pants, focusing on the waistband and edges, for any tears or defects.
- Dress the patient in the **MEDORAH® Colonoscopy Pants** before the procedure to avoid delays and ensure privacy.
- Ensure the opening with the attached cover is correctly positioned at the back. The opening allows access for the colonoscope while keeping the pants in place.
- Keep the pants in place throughout the procedure.
- Once the procedure is complete, carefully remove the pants.
- Discard the used pants as per hospital, local, and national biomedical waste disposal regulations.

#### **Cautions:**

- 1. Avoid contact with sharp or abrasive instruments or surfaces, which may cause damage or tearing of the material.
- **2.** This product is for hygienic protection of the patient.

#### Storage

Store the device under defined temperature limit and avoid direct sunlight Follow the First-in, First-out rules and do not use the device beyond its expiry date.

## **Change of performance**

If the device's performance is changed or the intended purpose is lost, further actions shall be taken according to the medical specialist's decision considering the clinical condition of patients.
